# TRAINING SEMINAR ON THE COMMEMORATION OF THE 21<sup>ST</sup> EDITION OF THE INTERNATIONAL ANTI-CORRUPTION DAY

9<sup>TH</sup> DECEMBER, 2024 IN BAFOUSSAM

### Ladies and Gentlemen,

Corruption is one of the causes of retarded development and institutional instability throughout the world today, and especially in our country. This scourge is notoriously detrimental to efforts to achieve economic development, equity and justice in human societies.

As a result, the United Nations decided, as a matter of urgency, to find ways and means of preventing and effectively combating corruption.

On the 31<sup>st</sup> of October, 2003, the UN General Assembly adopted the United Nations Convention against Corruption, which aims at strengthening anti-corruption measures, promoting integrity and facilitating international cooperation to better combat this transnational scourge.

At the same time, 9<sup>th</sup> December was declared International Anti-Corruption Day, a day to raise public awareness on the harmful effects of this social ill, to keep anticorruption stakeholders constantly on their toes, and to disseminate information about the role of the aforementioned Convention - the United Nations Convention against Corruption.

The global theme for the 21<sup>st</sup> International Anti-Corruption Day is **"Uniting with Youth against Corruption: Shaping Tomorrow's Integrity"**.

It is clear from this theme that integrity, which we have always presented as the most powerful weapon to fight corruption, is the foundation of good governance. If we succeed in passing on this patriotic vision to the younger generations, we will undoubtedly win the fight against this scourge.

### Ladies and Gentlemen,

Integrity is cultivated through education and reinforced through transparency promotion tools such as the digitisation of administrative procedures. This is why the main theme of this training seminar is: **"The Cameroon online E-procurement System (COLEPS) as a tool in the fight against corruption in public procurement"**. This theme is important for CONAC and other anti-corruption stakeholders.

Firstly, public contracts, or more generally public procurement, constitute a vulnerable area for corruption due to the huge financial resources at stake, allocated by the State budget.

Secondly, we are just a few days away from a new budgetary year.

And thirdly, by virtue of its constituting decree, CONAC has been entrusted with the task of carrying out physical and financial controls on the execution of projects, as well as evaluating the conditions under which public contracts are awarded.

Apart from the theme of COLEPS as a tool in the fight against corruption in public procurement, we will also address issues relating to:

- Rapid Results Initiative Data,
- Change management and
- The new approach to preparing the Anti-Corruption Status Report.

In the past, CONAC has achieved commendable results with a number of Ministries and public establishments, particularly with regard to Rapid Results Initiatives, an innovative approach to resolving a governance issue in 100 days. Unfortunately, this enthusiasm has faded over time. We hope that, with your contribution as strategic leaders in the implementation of RRIs, we will be able to give new impetus to this approach, which has proven its worth in the fight against corruption in our country.

### Ladies and Gentlemen,

We are therefore pleased to know that Anti-Corruption Units are succeeding in meeting the challenge of consistency in terms of participation in our meetings outside our various places of work. This is to the credit of the anti-corruption drive in our country. This fight therefore requires consistency, proximity and passion.

This commitment by each and every one of you to make your personal contribution and that of the institution that employs you is backed, rest assured, by the commitment of the President of the Republic, His Excellency Paul BIYA, to eradicate this scourge in our country. This determination was reaffirmed on 31<sup>st</sup> December, 2023, in his address to the Nation. we quote: "Actions implemented to combat corruption and misappropriation of public funds are essential for protecting public resources. They will be intensified in the coming year".

The theme for this 21<sup>st</sup> International Anti-Corruption Day encourages the 190 States parties to the United Nations Convention against Corruption to mobilise young people to adopt the principles of integrity. While working in line with the international theme, CONAC is placing this year's event, as we said yesterday, on the national theme: **"Let's make ethics and integrity the driving force of our country's emergence".**
